# 3rd Homeopathy Vijnana Sammelan 2023-24

#### **Summary:**

The Global Homeopathy Foundation, Vigyan Bharati and Innovative Thought Forum in association with the Homeopathic Medical association, Gujarat organised the 3rd in the series of Homeopathy Vijnana Sammelan at J B Auditorium, Ahmedabad Management Association, Ahmedabad on 24th Sept, 2023. The theme of the conference was "New Frontiers in Homeopathy".

The objective of the conference was to sensitise and showcase the strength of Homeopathy in the health care



delivery system within and outside its domains. The credibility of Homeopathy as a holistic health care is questioned by some quarters, not because of its therapeutic nihilism, but because homeopathy remained detached from the development of recent scientific developments. Understanding this lacune, the Global Homeopathy Foundation has taken steps to connect Homeopathic academia and research experts with main stream scientists in association with the Innovative Thought Forum and Vijana Bharati.

# The Inaugural session:

Mr S B Dangayach, Patron of GHF and a passionate supporter of safe medicine with revolutionary Ideas welcomed the gathering. He highlighted the conference is to create a global standard of healthcare and education in homeopathy, and to bring together experts from around the world to share knowledge and experience in this field. He stressed that Homeopathy has the potential to revolutionize the way we approach healthcare, and to provide affordable and effective treatment to people all over the world. This conference is to develop a safe eco system in line with the Vasudhaiva Kutumbakam concept of Indian ethos safeguarding not only the human health but the animal, plant and mineral kingdoms.

Dr Jayesh Sanghavi in his presidential address briefed about the Global Homeopathy Foundation and the conferences organised especially the two of the world's largest, path-breaking global events on fundamental research and Integrative Oncology. The GHF has joined hands with Vijnana Bharati — ViBha and Innovative Thought Forum (ITF) for the larger cause of elevating the stature of Homeopathy nationally and globally proposed a series of ten conferences across India for a multi-front Homeopathic empowerment capable of helping with solutions to some of the most worrying global health challenges that are the greatest concern of WHO and medical fraternities worldwide. This Series of HVS 2023-24 will culminate in a mega event in 2024. The ultimate mission behind this humongous exercise is to build a platform for the vertical rise and acceptance of Homeopathy across nations.

The Chief Guest of the function was Dr G N Singh, Advisor to Honourable Chief Minister, Uttar Pradesh and Former Drug Controller General of India. He highlighted that Homeopathy has a long history of being a safe and effective medicine that has been used for centuries. As communities around the world continue to seek holistic approaches to healing and wellness, the need for high quality education and research in the field of homeopathy is more important than ever. Dr Singh also suggested that one such event might be organised in the State of Utter Pradesh.

Dr Eswara Das, the Patron of GHF honoured seven eminent personalities in Homeopathy from the state of Gujarat during the event. Dr Praveen Kumar, Secretary GHF, moderated the function and Dr Sreevals Gopinath made the Vote of Thanks.



#### **Scientific Sessions:**

The first session was on Rational, affordable, and speedy NDCTR for Homeopathy Dr Raj K Manchanda, the former DG, CCRH and Director (AYUSH) Govt of Delhi moderated the session and presented a panoramic view on the existing Drug Regulation in Homeopathy and the recent initiatives by the Government to make it comprehensive. Ms, Geeta Taele, Partner Clinical solutions LLP Navi Mumbai, and Dr Sanjeev Acharya, Principal, SSR College of Pharmacy, Silvassa also made their presentation on innovating the Homeopathic products, which are getting wider acceptability among the public. Dr Anil Khurana, the Chairman of National Commission on Homeopathy could not attend the session due to indisposition.

The overall thrust was that there is an urgent need for regulatory frame work for NDCTR in Homeopathy. The Classical Homeopathic preparations are regulated through the Homeopathic Pharmacopeial frame work, however, the Homeopathic products including the nutraceuticals, cosmetics, Veterinary and Agri-care products do not have a regulatory frame work. This is an important area where standards need to be brought in through proper clinical trials for better credibility and competitiveness. This also offers tremendous scope for patenting the products by the industry and offers much opportunity to the PhD programs.

The second session was on Low hanging opportunities in Homeopathy with high potential. Dr S P S Bakshi, CMD, Bakson group of Institutions was the key speaker, but informed his inability.

Dr Dinesh Dua Former Chairman, Pharma Expo Council, Dr Sudipta Narayan Roy, M D Powel Laboratories (P) Ltd, Dr Rajesh Shah, Practicing Homeopath, Political activist and Pharma CEO from Vadodara and Shri Mridul Goel, Director, M/S Goel Pharma Laboratories presented papers on the high opportunities in Homeopathy which are otherwise considered clinically less important like use of Biochemic remedies in mal absorption and mal assimilation, use of Calendula and arnica in wound healing etc. Such economically viable options could be used in public health care delivery system as cost effective and nontoxic alternatives.

Relevance of Homeopathy for public health, hospitals, and Integrative health care was the third session. Dr Dileep Mavlankar Former Director, IIHP, Gandhinagar., Dr Juhi Gupta, Govt Homeopathic Medical College, Bhopal, Dr Abdul Ghafur, Consultant, Infectious Diseases, Apollo Hospital, Chennai and Mr Pradeep Borar IAS, Rajasthan were the speakers. It was one of the most vibrant sessions, where the limitations of different medical systems and the challenges in the present-day health care delivery system was deliberated in detail. The scope of homeopathy to meet some of these challenges was highlighted. The session brought in the importance of high-end research involving multi-disciplinary approaches to validate the claims in Homeopathy. The session also called up on the organisers to take up this issue urgently with appropriate authorities and the speakers assured support to involve themselves to find solutions to this grave challenge through Homeopathic research. It also suggested for standard protocols and pragmatic solutions in preventive and promotive health through Homeopathic principles.

The fourth session was on Veterinary Homeopathy – A must for One Health program. Dr Surjit Singh Makker, renowned Veterinarian and former Joint Director, Govt of Punjab, PDr Vikram Jani, Amul Veterinary Homeo Unit, Amul Dairy, Dr Poshak Patel, manging Director, Gujarat Sheep and Wool Development corporation, Dr Shivang Swaminarayan, Homeopathic Consultant, Gujarat presented papers on various issues related to Animal health and the Homeopathic approaches for easy, effective, and safe solutions



#### **Panel Discussion:**

The theme of the Pannel discussion was on Vasudhaiva Kutumbakam and on how to popularise the strength on Homeopathy in Public health delivery system to create a holistic, integrative inclusive pluralistic safe health system which would be affordable, easily reachable, ecofriendly with least carbon imprint. The Panellists were Shri S B Dangayach from Innovative Thought Forum, Shri P C. Pande IPS, Former DGP, Gujarat, Dr Nandini Sharma, Homeopathic Consultant from New Delhi, Dr Prakash Joshi, Vice President of Medicynth, Mumbai.

The delegates were limited to 450 off line and about 2000 participants joined through direct Youtube link and about 5000 viewed the conference through external, links from across the world attended the conference. About 50% delegates were from homeopathy and remaining were from different branches of Science & Technology, Biomedicine, Management trainees and experts, Lovers of Homeopathy, Veterinary and Agri-care students/ experts. The Speakers were also be eminent personalities from different dimensions of Science, Philosophy and Public life who gave an outsider's perspective on Homeopathy, which is considered essential to take forward the system in future Global health care.

### **Valedictory Function:**

The valedictory speech was given by given by Padmashree V Prakash, who emphatically stressed to formulate small groups of experts in each of the topics and prepare recommendations to the concerned authorities for implantation. He observed that this was a momentous occasion to collate opinions and views on Drug laws related to Homeopathy, especially the New clinical trial strategy and NDCTR. Also, we are deliberating the extend of developing Homeopathy in veterinary practice and Agri Care. Low hanging opportunities in Homeopathy is having very high potential especially in long term, lifestyle and chronic conditions which are having very less scope in other medical system other than management. If Homeopaths uses the management options available in other medical system and use their therapeutic modalities, it would give the best treatment option not for management alone, but for curing the illness. Use of Naturopathy, Homeopathy, Yoga and such therapies will help in evolving a new paradigm in health care.

#### **Conclusion:**

It was indeed a very educative conference for the Homeopathic fraternity as well for the lovers of Homeopathy. The conference debated on many untapped areas in Homeopathy that can be great businesses opportunities. GHF now has a lot on it's plate including thought leadership in Homeopathy and policy support to translate some of the ideas, research etc into programmes or impactful enterprises.

This was a momentous occasion to collate opinions and views on Drug laws related to Homeopathy, especially the New clinical trial strategy and NDCTR. Also, we are deliberating the scope of developing Homeopathy in veterinary practice and Agri Care.
